A delayed but nonetheless welcome to 2022 and to rewarding school community activities. A very warm welcome to families and students that are new to the Ironside community.

The P&C is looking forward to the year ahead, having committed to spend more than half a million dollars for works to improve facilities for Ironside students.

Each year the P&C raises funds for the benefit of all students through a P&C Contribution Program to support the school (except for last year, due to COVID-19 uncertainties and P&C reporting a strong balance sheet, P&C instead asked for giving of your time). Past fundraising efforts included the Tuckshop renovation, the grassy patch playground refurbishment, music instrument upgrade and Uniform Shop fit out. In 2021, new industrial fans were installed in the school hall and new pool covers and a pool butler were purchased in collaboration with the school.

We ask for your financial support to continue to provide quality, beneficial enhancements to our school. Qkr! is also used for ordering from the Tuckshop and Uniform Shop and purchasing tickets for P&C organised events.
